ORDER MODIFYING SCHEDULE

1 This matter comes before the Court on the parties' Stipulated Motion to Rernote Trial  
2 Date (Dkt. No. 232). The parties have stipulated to move the trial date from October 4, 2010 to  
3 November 15, 2010. In addition, the parties have agreed to stay all discovery for five weeks  
4 (35 days) in order to focus their efforts on the prospects of settlement. As a result, the Court  
5 sets the following deadlines, as requested by the parties:

- 6 • The trial date for this matter is reset from October 4, 2010 to **November 15, 2010**.
- 7 • Discovery will be neither propounded nor responded to for a period of 35 days,  
8 beginning on May 5, 2010 and extending through June 8, 2010.
- 9 • With respect to discovery already propounded, the 30-day time to respond will resume,  
10 with time elapsed, on June 9, 2010. Consequently:
  - 11 ○ State Defendant Intervenors' responses to discovery propounded by Plaintiffs  
12 and Plaintiff Intervenors on April 30 will be due July 6;
  - 13 ○ Plaintiffs' and Plaintiff Intervenors' responses to discovery propounded by State  
14 Defendant Intervenors on May 4 will be due July 8.
- 15 • Deadline to propound written discovery: June 9, 2010;
- 16 • Deadline to exhaust written discovery: July 16, 2010;
- 17 • Deadline to conduct fact witness depositions: August 17, 2010;
- 18 • Deadline to conduct expert depositions: August 20, 2010;
- 19 • Deadline for dispositive motions: August 26, 2010.
