1 AN ACT Relating to civil forfeitures of property; amending RCW
2 69.50.505, 9A.83.030, and 69.50.520; and creating new sections.

3 BE IT ENACTED BY THE PEOPLE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** The people of the state of Washington find
5 the current practice of asset forfeiture to be unjust and, therefore,
6 find it necessary to reform existing property forfeiture laws. Justice
7 requires that the most important duty of government is the preservation
8 of all of the rights of all of its citizens. Washingtonians have had
9 their property taken from them in civil forfeiture actions without the
10 benefit of fair procedures designed to protect their rights. No person
11 should have property civilly forfeited unless that person has been
12 found guilty of a crime related to the property, and then only if the
13 value of the property taken is substantially proportionate to the
14 seriousness of the offense.

15 NEW SECTION. **Sec. 2.** This act may be known and cited as the
16 innocent property owners protection act.

1 **Sec. 3.** RCW 69.50.505 and 2001 c 168 s 1 are each amended to read
2 as follows:

3 (a) No judgment of forfeiture of property in a civil forfeiture
4 proceeding under this section by the state or any of its political
5 subdivisions shall be allowed or entered until and unless the owner of
6 the property is convicted of a criminal violation of this chapter or an
7 equivalent crime in another jurisdiction and the state demonstrates by
8 clear and convincing evidence that the property was instrumental in
9 committing or facilitating the crime or the property is proceeds of
10 that crime. The value of the property forfeited under the provisions
11 of this subsection shall be substantially proportional to the specific
12 conduct for which the owner of the property has been convicted.

13 (b) In a civil forfeiture proceeding, if a financial institution
14 claiming an interest in the property demonstrates that it holds an
15 interest, its interest shall not be subject to forfeiture. In a civil
16 forfeiture proceeding, if a person claiming an interest in the
17 property, other than a financial institution or a defendant who has
18 been charged with or convicted of a crime involving that property,
19 demonstrates that the person has an interest in the property, that
20 person's interest shall not be subject to forfeiture unless:

21 (1) The forfeiting agency proves by clear and convincing evidence
22 that the person took the property or the interest with the intent to
23 defeat the forfeiture; or

24 (2) A conviction under subsection (a) of this section is later
25 obtained against the person.

26 (c) Notwithstanding the provisions of subsection (a) of this
27 section, and subject to subsection (p) of this section, if, following
28 notice as required in this section, no person claims an interest in the
29 seized property or if the property is contraband, a judgment of
30 forfeiture may be allowed and entered without a criminal conviction as
31 provided in subsection (i) of this section.

32 (d) Nothing in this section may be construed to affect the
33 temporary seizure of property for evidentiary, forfeiture, or
34 protective purposes, or to alter the power of the governor to remit
35 finances or forfeitures under Article III, section 11 of the Washington
36 state Constitution.

37 (e) The following are subject to seizure and forfeiture ((and no
38 property right exists in them)) in accordance with subsections (a)
39 through (d) of this section:

1 (1) All controlled substances which have been manufactured,
2 distributed, dispensed, acquired, or possessed in violation of this
3 chapter or chapter 69.41 or 69.52 RCW, and all hazardous chemicals, as
4 defined in RCW 64.44.010, used or intended to be used in the
5 manufacture of controlled substances;

6 (2) All raw materials, products, and equipment of any kind which
7 are used, or intended for use, in manufacturing, compounding,
8 processing, delivering, importing, or exporting any controlled
9 substance in violation of this chapter or chapter 69.41 or 69.52 RCW;

10 (3) All property which is used, or intended for use, as a container
11 for property described in ((paragraphs)) (1) or (2) of this subsection;

12 (4) All conveyances, including aircraft, vehicles, or vessels,
13 which are used, or intended for use, in any manner to facilitate the
14 sale, delivery, or receipt of property described in ((paragraphs)) (1)
15 or (2) of this subsection, except that((+)

16 (i) ~~No conveyance used by any person as a common carrier in the~~
17 ~~transaction of business as a common carrier is subject to forfeiture~~
18 ~~under this section unless it appears that the owner or other person in~~
19 ~~charge of the conveyance is a consenting party or privy to a violation~~

21 (ii) ~~No conveyance is subject to forfeiture under this section by~~

28 ~~security interest is subject to the interest of the secured party if~~
29 ~~the secured party neither had knowledge of nor consented to the act or~~
30 ~~omission; and~~

31 (v) ~~When the owner of a conveyance has been arrested under this~~
32 ~~chapter or chapter 69.41 or 69.52 RCW the conveyance in which the~~
33 ~~person is arrested may not be subject to forfeiture unless it is seized~~
34 ~~or process is issued for its seizure within ten days of the owner's~~
35 ~~arrest;))~~

36 (5) All books, records, and research products and materials,
37 including formulas, microfilm, tapes, and data which are used, or
38 intended for use, in violation of this chapter or chapter 69.41 or
39 69.52 RCW;

1 (6) All drug paraphernalia;

2 (7) All moneys, negotiable instruments, securities, or other
3 tangible or intangible property of value furnished or intended to be
4 furnished by any person in exchange for a controlled substance in
5 violation of this chapter or chapter 69.41 or 69.52 RCW, all tangible
6 or intangible personal property, proceeds, or assets acquired in whole
7 or in part with proceeds traceable to an exchange or series of
8 exchanges in violation of this chapter or chapter 69.41 or 69.52 RCW,
9 and all moneys, negotiable instruments, and securities used or intended
10 to be used to facilitate any violation of this chapter or chapter 69.41
11 or 69.52 RCW(~~(. — A forfeiture of money, negotiable instruments,~~
12 ~~securities, or other tangible or intangible property encumbered by a~~

16 ~~No personal property may be forfeited under this paragraph, to the~~

20 the crime for which the owner was convicted and the money, negotiable
21 instruments, and securities; and~~

22 (8) All real property, including any right, title, and interest in
23 the whole of any lot or tract of land, and any appurtenances or
24 improvements which are being used with the knowledge of the owner for
25 the manufacturing, compounding, processing, delivery, importing, or
26 exporting of any controlled substance, or which have been acquired in
27 whole or in part with proceeds traceable to an exchange or series of
28 exchanges in violation of this chapter or chapter 69.41 or 69.52 RCW,
29 if such activity is not less than a class C felony and a substantial
30 nexus exists between the commercial production or sale of the
31 controlled substance and the real property. However:

32 (i) (~~No property may be forfeited pursuant to this subsection, to~~
33 ~~the extent of the interest of an owner, by reason of any act or~~
34 ~~omission committed or omitted without the owner's knowledge or consent;~~

35 (ii)) The bona fide gift of a controlled substance, legend drug,
36 or imitation controlled substance shall not result in the forfeiture of
37 real property;

38 ((~~iii~~)) (ii) The possession of marijuana shall not result in the
39 forfeiture of real property unless the marijuana is possessed for

1 commercial purposes, the amount possessed is five or more plants or one
2 pound or more of marijuana, and a substantial nexus exists between the
3 possession of marijuana and the real property. In such a case, the
4 intent of the offender shall be determined by the preponderance of the
5 evidence, including the offender's prior criminal history, the amount
6 of marijuana possessed by the offender, the sophistication of the
7 activity or equipment used by the offender, and other evidence which
8 demonstrates the offender's intent to engage in commercial activity;
9 and

10 ~~((iv))~~ (iii) The unlawful sale of marijuana or a legend drug
11 shall not result in the forfeiture of real property unless the sale was
12 forty grams or more in the case of marijuana or one hundred dollars or
13 more in the case of a legend drug, and a substantial nexus exists
14 between the unlawful sale and the real property(~~;~~ and

15 ~~(v) A forfeiture of real property encumbered by a bona fide~~
16 ~~security interest is subject to the interest of the secured party if~~
17 ~~the secured party, at the time the security interest was created,~~
18 ~~neither had knowledge of nor consented to the act or omission)).~~

19 ~~((b))~~ (f) Real or personal property subject to forfeiture under
20 this chapter may be seized by any board inspector or law enforcement
21 officer of this state upon process issued by any superior court having
22 jurisdiction over the property. Seizure of real property shall include
23 the filing of a lis pendens by the seizing agency. Real property
24 seized under this section shall not be transferred or otherwise
25 conveyed ~~((until ninety days after seizure or))~~ until a judgment of
26 forfeiture is entered(~~(, whichever is later:— PROVIDED, That))~~.
27 However, real property seized under this section may be transferred or
28 conveyed to any person or entity who acquires title by foreclosure or
29 deed in lieu of foreclosure of a security interest.

30 (g) Seizure of personal property without process may be made if:

31 (1) The seizure is incident to an arrest or a search under a search
32 warrant or an inspection under an administrative inspection warrant;

33 (2) The property subject to seizure has been the subject of a prior
34 judgment in favor of the state in a criminal injunction or forfeiture
35 proceeding based upon this chapter; or

1 ~~(4) The board inspector or law enforcement officer has probable~~

4 ~~((e))~~ (h)(1) In the event of seizure pursuant to subsection
5 ~~((b))~~ (f) or (g) of this section, proceedings for forfeiture shall be
6 deemed commenced by the seizure. The law enforcement agency under
7 whose authority the seizure was made shall cause notice to be served
8 within ~~((fifteen))~~ ten days following the seizure on the owner of the
9 property seized and the person in charge thereof and any person having
10 any known right or interest therein, including any community property
11 interest, of the seizure and intended forfeiture of the seized
12 property. The notice must include a statement that the owner of the
13 property or any person having any known right or interest in the
14 property may request, in writing, that the seizing agency appear in a
15 hearing before a court of competent jurisdiction to show that probable
16 cause exists to seize the property. Service of notice of seizure of
17 real property shall be made according to the rules of civil procedure.
18 However, the state may not obtain a ~~((default))~~ judgment with respect
19 to real property against a party ~~((who is served by substituted service~~
20 ~~absent an affidavit stating that a good faith effort has been made to~~
21 ~~ascertain if the defaulted party is incarcerated within the state, and~~

24 Notice of seizure in the case of property subject to a security
25 interest that has been perfected by filing a financing statement in
26 accordance with chapter 62A.9A RCW, or a certificate of title, shall be
27 made by service upon the secured party or the secured party's assignee
28 at the address shown on the financing statement or the certificate of
29 title. The notice of seizure in ~~((other))~~ cases involving only
30 personal property may be served by any method authorized by law or
31 court rule including but not limited to service by certified mail with
32 return receipt requested. Service by mail shall be deemed complete upon
33 mailing within the ~~((fifteen))~~ ten-day period following the seizure.

34 ~~((d))~~ (2) Within twenty days of receiving notice of the seizure
35 of personal property, the owner of the property or any person having
36 any known right or interest in the property may serve upon the seizing
37 agency a written request for a hearing before a court of competent
38 jurisdiction to determine that probable cause exists for the seizure
39 and detention of property pending the outcome of the forfeiture

1 proceedings. Within seventy-two hours of receiving the written request
2 for a hearing, the seizing agency shall cause a hearing to be held
3 before a court of competent jurisdiction. The seizing agency must show
4 cause why the property was lawfully seized and should be held pending
5 forfeiture proceedings. If the court finds probable cause did not
6 exist for seizure, the property shall be immediately returned to the
7 owner of the property or person having an interest in the property,
8 unless the seizing agency demonstrates that the property should be held
9 for evidentiary purposes in a pending criminal proceeding. If property
10 is held under this subsection for evidentiary purposes, the property
11 not forfeited shall be returned to the owner or person having an
12 interest in the property upon adjudication of the criminal proceedings.

13 (i) If no person notifies the seizing law enforcement agency in
14 writing of the person's claim of ownership or right to possession of
15 items specified in subsection ~~((a))~~ (e)(4), ~~((a))~~(7), or ~~((a))~~(8)
16 of this section within forty-five days of the seizure in the case of
17 personal property and ninety days in the case of real property, the
18 item seized shall be deemed forfeited. The community property interest

23 agency in writing of the person's claim of ownership or right to

6 when the aggregate value of personal property is within the

21 (5) Destroy any property that is harmful to the public, required to
22 be destroyed by law, or otherwise not appropriate for sale to the
23 public.

24 The provisions of this subsection requiring the seizing agency to
25 keep records and file quarterly reports apply to all forfeited property
26 the seizing agency receives under federal seizure and forfeiture laws.
27 The seizing agency must specify from which federal agencies it receives
28 funds. Seizing agencies that receive forfeited property under the
29 federal seizure and forfeiture laws are required to use such forfeited
30 property and proceeds pursuant to federal restrictions, and the
31 reporting requirement does not require the seizing agency to remit
32 federal funds to the state.

33 (n)(1)(i) By January 31st of each year, each seizing agency shall
34 remit to the state treasurer an amount equal to ten percent of the net
35 proceeds of any property forfeited during the preceding calendar year.
36 Money remitted shall be deposited in the violence reduction and drug
37 enforcement account under RCW 69.50.520.

38 (ii) By January 31st of the year, each seizing agency shall remit
39 to the state treasurer an amount equal to ninety percent of the net

1 proceeds of any property forfeited during the preceding calendar year.
2 One-half of the money remitted shall be deposited in the permanent
3 common school fund and the remaining one-half shall be allocated to
4 public drug treatment programs as provided by law.

5 (2) The net proceeds of forfeited property is the value of the
6 forfeitable interest in the property after deducting: (i) The cost of
7 satisfying any bona fide security interest to which the property is
8 subject at the time of seizure; and in the case of sold property, after
9 deducting the cost of sale, including reasonable fees or commissions
10 paid to independent selling agents, and the cost of any valid
11 landlord's claim for damages under subsection ((+o+)) (r) of this
12 section; (ii) any foreclosed liens, security interest, and contracts in
13 the order of their priority; and (iii) actual and reasonable expenses
14 related to the costs of the forfeiture proceeding, including attorneys'
15 fees, storage, maintenance, management, and disposition of the property
16 incurred in connection with the sale of any forfeited property in an
17 amount not to exceed twenty-five percent of the total proceeds in any
18 single forfeiture.

37 (1) Any sale of forfeited property shall be conducted in a
38 commercially reasonable manner. Property or proceeds forfeited under

1 this section shall be distributed or applied as required by subsection

3 (2) The state of Washington or any of its political subdivisions
4 shall take all necessary steps to obtain shared property or proceeds
5 from the United States department of justice resulting from a
6 forfeiture. Any property or proceeds received from the United States
7 department of justice by the state of Washington or any of its
8 political subdivisions shall be applied as provided in (1) of this
9 subsection.

10 (3) Neither the state of Washington, its political subdivisions,
11 nor any forfeiting agency shall transfer forfeiture proceedings to the

30 (1) Proceeds traceable to or derived from specified unlawful
31 activity or a violation of RCW 9A.83.020 are subject to seizure and
32 forfeiture. The attorney general or county prosecuting attorney may
33 file a civil action for the forfeiture of proceeds. Unless otherwise
34 provided for under this section, no property rights exist in these
35 proceeds. All right, title, and interest in the proceeds shall vest in
36 the governmental entity of which the seizing law enforcement agency is
37 a part upon commission of the act or omission giving rise to forfeiture
38 under this section.

1 (2) Real or personal property subject to forfeiture under this
2 chapter may be seized by any law enforcement officer of this state upon
3 process issued by a superior court that has jurisdiction over the
4 property. Any agency seizing real property shall file a lis pendens
5 concerning the property. Real property seized under this section shall
6 not be transferred or otherwise conveyed until ninety days after
7 seizure or until a judgment of forfeiture is entered, whichever is
8 later. Real property seized under this section may be transferred or
9 conveyed to any person or entity who acquires title by foreclosure or
10 deed in lieu of foreclosure of a security interest. Seizure of
11 personal property without process may be made if:

12 (a) The seizure is incident to an arrest or a search under a search
13 warrant or an inspection under an administrative inspection warrant
14 issued pursuant to RCW 69.50.502; or

15 (b) The property subject to seizure has been the subject of a prior
16 judgment in favor of the state in a criminal injunction or forfeiture
17 proceeding based upon this chapter.

18 (3) A seizure under subsection (2) of this section commences
19 proceedings for forfeiture. The law enforcement agency under whose
20 authority the seizure was made shall cause notice of the seizure and
21 intended forfeiture of the seized proceeds to be served within fifteen
22 days after the seizure on the owner of the property seized and the
23 person in charge thereof and any person who has a known right or
24 interest therein, including a community property interest. Service of
25 notice of seizure of real property shall be made according to the rules
26 of civil procedure. However, the state may not obtain a default
27 judgment with respect to real property against a party who is served by
28 substituted service absent an affidavit stating that a good faith
29 effort has been made to ascertain if the defaulted party is
30 incarcerated within the state, and that there is no present basis to
31 believe that the party is incarcerated within the state. The notice of
32 seizure in other cases may be served by any method authorized by law or
33 court rule including but not limited to service by certified mail with
34 return receipt requested. Service by mail is complete upon mailing
35 within the fifteen-day period after the seizure.

36 (4) If no person notifies the seizing law enforcement agency in
37 writing of the person's claim of ownership or right to possession of
38 the property within forty-five days of the seizure in the case of
39 personal property and ninety days in the case of real property, the

1 property seized shall be deemed forfeited. The community property
2 interest in real property of a person whose spouse committed a
3 violation giving rise to seizure of the real property may not be
4 forfeited if the person did not participate in the violation.

5 (5) If a person notifies the seizing law enforcement agency in
6 writing of the person's claim of ownership or right to possession of
7 property within forty-five days of the seizure in the case of personal
8 property and ninety days in the case of real property, the person or
9 persons shall be afforded a reasonable opportunity to be heard as to

19 The violence reduction and drug enforcement account is created in
20 the state treasury. All designated receipts from RCW 9.41.110(8),
21 66.24.210(4), 66.24.290(2), 69.50.505(~~(i)~~) (n)(1), 82.08.150(5),
22 82.24.020(2), 82.64.020, and section 420, chapter 271, Laws of 1989
23 shall be deposited into the account. Expenditures from the account may
24 be used only for funding services and programs under chapter 271, Laws
25 of 1989 and chapter 7, Laws of 1994 sp. sess., including state
26 incarceration costs. Funds from the account may also be appropriated
27 to reimburse local governments for costs associated with implementing
28 criminal justice legislation including chapter 338, Laws of 1997.

5 compliance with RCW 69.50.505 (m), (n), and (o). The state auditor
6 shall produce written findings regarding compliance and submit a report
7 to the legislature within a reasonable time after each audit period.

8 NEW SECTION. **Sec. 7.** If any provision of this act or its
9 application to any person or circumstance is held invalid, the
10 remainder of the act or the application of the provision to other
11 persons or circumstances is not affected.
