AN ACT Relating to open ballot voting; amending RCW 29A.20.121,
29A.20.161, 29A.20.171, 29A.20.200, 29A.20.201, 29A.24.050, 29A.36.121,
29A.36.201, and 29A.60.200; adding a new section to chapter 29A.60 RCW;
and creating new sections.

5 BE IT ENACTED BY THE PEOPLE OF THE STATE OF WASHINGTON:

The people of Washington value their 6 NEW SECTION. Sec. 1. 7 tradition of independent voting and value the freedom to vote for the 8 candidate they prefer and the party they most closely identify with. 9 The people find that Washington law should allow more than one 10 political party to nominate the same candidate for the same office. This measure is intended to allow a candidate to receive the nomination 11 12 of more than one political party. A candidate would still be able to 13 receive no more than one vote per ballot but any votes the candidate 14 receives would count toward the candidate's vote total.

15 Sec. 2. RCW 29A.20.121 and 2004 c 271 s 110 are each amended to 16 read as follows:

17 (1) Any nomination of a candidate for partisan public office by18 other than a major political party may be made only: (a) In a

1 convention held not ((earlier than the last Saturday in June and not 2 later than the first Saturday in July or during any of the seven days immediately preceding the first day for filing declarations of 3 candidacy as fixed in accordance with RCW 29A.28.041)) later than 4 forty-five days prior to the general election; (b) as provided by RCW 5 29A.60.021; or (c) as otherwise provided in this section. Minor 6 7 political party and independent candidates may appear only on the 8 general election ballot.

9 (2) ((Nominations of candidates for president and vice president of the United States other than by a major political party may be made 10 11 either at a convention conducted under subsection (1) of this section, 12 or at a similar convention taking place not earlier than the first 13 Sunday in July and not later than seventy days before the general 14 election. Conventions held during this time period may not nominate 15 candidates for any public office other than president and vice 16 president of the United States, except as provided in subsection (3) of 17 this section.

(3)) If a special filing period for a partisan office is opened 18 under RCW 29A.24.211, candidates of minor political parties and 19 20 independent candidates may file for office during that special filing 21 period. The names of those candidates may not appear on the general 22 election ballot unless they are nominated by convention held no later 23 than five days after the close of the special filing period and a 24 certificate of nomination is filed with the filing officer no later 25 than three days after the convention. The requirements of RCW 26 29A.20.131 do not apply to such a convention.

27 (((4))) <u>(3)</u> A minor political party may hold more than one 28 convention but in no case shall any such party nominate more than one 29 candidate for any one partisan public office or position. For the 30 purpose of nominating candidates for the offices of president and vice 31 president, United States senator, United States representative, or a 32 statewide office, a minor party or independent candidate holding 33 multiple conventions may add together the number of signatures of 34 different individuals from each convention obtained in support of the candidate or candidates in order to obtain the number required by RCW 35 29A.20.141. For all other offices for which nominations are made, 36 signatures of the requisite number of registered voters must be 37 38 obtained at a single convention.

1 Sec. 3. RCW 29A.20.161 and 2004 c 271 s 154 are each amended to 2 read as follows:

3

A certificate evidencing nominations made at a convention must:

4 (1) Be in writing;

5 (2) Contain the name of each person nominated, his or her 6 residence, and the office for which he or she is named, and ((if the 7 nomination is for the offices of president and vice president of the 8 United States,)) a sworn statement from ((both)) each nominee((s)) 9 giving ((their)) his or her consent to the nomination;

10 (3) Identify the minor political party or the independent candidate11 on whose behalf the convention was held;

12 (4) Be verified by the oath of the presiding officer and secretary; 13 (5) Be accompanied by a nominating petition or petitions bearing 14 the signatures and addresses of registered voters equal in number to 15 that required by RCW 29A.20.141;

16 (6) Contain proof of publication of the notice of calling the 17 convention; and

18 (7) Be submitted to the appropriate filing officer not later than 19 one ((week)) day following the adjournment of the convention at which 20 the nominations were made. If the nominations are made only for 21 offices whose jurisdiction is entirely within one county, the 22 certificate and nominating petitions must be filed with the county 23 auditor. If a minor party or independent candidate convention nominates any candidates for offices whose jurisdiction encompasses 24 25 more than one county, all nominating petitions and the convention 26 certificates must be filed with the secretary of state.

27 **Sec. 4.** RCW 29A.20.171 and 2004 c 271 s 155 are each amended to 28 read as follows:

29 (1) If two or more valid certificates of nomination are filed purporting to nominate different candidates for the same position using 30 31 the same party name, the filing officer must give effect to both 32 certificates. <u>A minor political party may establish rules by which any</u> 33 conflicting claims to the party name shall be resolved. If conflicting 34 claims to the party name are not resolved ((either)) under party rules, 35 by mutual agreement, or by a judicial determination of the right to the 36 name, the candidates must be treated as independent candidates. 37 Disputes over the right to the name must not be permitted to delay the 38 printing of either ballots or a voters' pamphlet. Other candidates

1 nominated by the same conventions may continue to use the partisan 2 affiliation unless a court of competent jurisdiction directs otherwise.

3 (2) A person affected may petition the superior court of the county 4 in which the filing officer is located for a judicial determination of 5 the right to the name of a minor political party, either before or after documents are filed with the filing officer. Upon the filing of 6 7 the petition on appeal, the court shall immediately, or at a time consented to by the appellants, examine the conflict between competing 8 9 claims and may hear arguments on it, and shall as soon as possible render its decision. The court shall resolve the conflict between 10 11 competing claims to the use of the same party name according to the 12 following principles: (a) The prior established public use of the name 13 during previous elections by a party composed of or led by the same 14 individuals or individuals in documented succession; (b) prior 15 established public use of the name earlier in the same election cycle; 16 (c) the nomination of a more complete slate of candidates for a number 17 of offices or in a number of different regions of the state; (d) 18 documented affiliation with a national or statewide party organization 19 with an established use of the name; (e) the first date of filing of a 20 certificate of nomination; and (f) such other indicia of an established 21 right to use of the name as the court may deem relevant. If more than 22 one filing officer is involved, and one of them is the secretary of 23 state, the petition must be filed in the superior court for Thurston 24 county. Upon resolving the conflict between competing claims, the 25 court may also address any ballot designation for the candidate who 26 does not prevail.

27 **Sec. 5.** RCW 29A.20.200 and 2003 c 111 s 514 are each amended to 28 read as follows:

29 Not later than ((the Friday immediately preceding the first day for 30 candidates to file)) forty days prior to the general election, the secretary of state shall notify the county auditors of the names and 31 32 designations of all minor party and independent candidates who have 33 filed valid convention certificates and nominating petitions with that 34 office. Except for the offices of president and vice president, 35 persons nominated under this chapter shall file declarations of candidacy as provided by RCW ((29A.24.030)) 29A.24.031 and 29A.24.070. 36 37 ((The name of a candidate nominated at a convention shall not be 38 printed upon the primary ballot unless he or she pays the fee required

by law to be paid by candidates for the same office to be nominated at a primary.))

3 Sec. 6. RCW 29A.20.201 and 2004 c 271 s 113 are each amended to 4 read as follows:

5 Not later than ((the Friday immediately preceding the first day for candidates to file)) forty days prior to the general election, the 6 secretary of state shall notify the county auditors of the names and 7 designations of all minor party and independent candidates who have 8 9 filed valid convention certificates and nominating petitions with that 10 office. Except for the offices of president and vice president, 11 persons nominated under this chapter shall file declarations of candidacy as provided by RCW 29A.24.031 and 29A.24.070. The name of a 12 13 candidate nominated at a convention shall not be printed upon the 14 general election ballot unless he or she pays the fee required by law 15 to be paid by candidates for the same office to be nominated at a 16 primary.

17 **Sec. 7.** RCW 29A.24.050 and 2003 c 111 s 605 are each amended to 18 read as follows:

Except where otherwise provided by this title <u>or by minor party</u> nomination under chapter 29A.20 RCW, declarations of candidacy for the following offices shall be filed during regular business hours with the filing officer no earlier than the fourth Monday in July and no later than the following Friday in the year in which the office is scheduled to be voted upon:

(1) Offices that are scheduled to be voted upon for full terms or
both full terms and short terms at, or in conjunction with, a state
general election; and

(2) Offices where a vacancy, other than a short term, exists that has not been filled by election and for which an election to fill the vacancy is required in conjunction with the next state general election.

32 This section supersedes all other statutes that provide for a 33 different filing period for these offices.

34 **Sec. 8.** RCW 29A.36.121 and 2004 c 271 s 129 are each amended to 35 read as follows:

1 (1)(a) The positions or offices on a primary consolidated ballot 2 shall be arranged in substantially the following order: United States 3 senator; United States representative; governor; lieutenant governor; secretary of state; state treasurer; state auditor; attorney general; 4 5 commissioner of public lands; superintendent of public instruction; insurance commissioner; state senator; state representative; county 6 7 officers; justices of the supreme court; judges of the court of 8 appeals; judges of the superior court; and judges of the district 9 court. For all other jurisdictions on the primary consolidated ballot, the offices in each jurisdiction shall be grouped together and be in 10 11 the order of the position numbers assigned to those offices, if any.

12 (b)(i) The positions or offices on a primary party ballot must be 13 arranged in substantially the following order: United States senator; 14 United States representative; governor; lieutenant governor; secretary 15 of state; state treasurer; state auditor; attorney general; commissioner of public lands; insurance commissioner; state senator; 16 state representative; and partisan county officers. For all other 17 18 jurisdictions on the primary party ballot, the offices in each 19 jurisdiction must be grouped together and be in the order of the 20 position numbers assigned to those offices, if any.

(ii) The positions or offices on a primary nonpartisan ballot must be arranged in substantially the following order: Superintendent of public instruction; justices of the supreme court; judges of the court of appeals; judges of the superior court; and judges of the district court. For all other jurisdictions on the primary nonpartisan ballot, the offices in each jurisdiction must be grouped together and be in the order of the position numbers assigned to those offices, if any.

28 (2) The order of the positions or offices on an election ballot 29 shall be substantially the same as on a primary consolidated ballot 30 except that state ballot issues must be placed before all offices. The 31 offices of president and vice president of the United States shall 32 precede all other offices on a presidential election ballot. The 33 positions on a ballot to be assigned to ballot measures regarding local 34 units of government shall be established by the secretary of state by 35 rule.

36 (3) The political party or independent candidacy of each candidate 37 for partisan office shall be indicated next to the name of the 38 candidate on the primary and election ballot. (A candidate shall file 39 a written notice with the filing officer within three business days

1 after the close of the filing period designating the political party to 2 be indicated next to the candidate's name on the ballot if either: (a) The candidate has been nominated by two or more minor political parties 3 or independent conventions; or (b) the candidate has both filed a 4 declaration of candidacy declaring an affiliation with a major 5 political party and been nominated by a minor political party or 6 7 independent convention. If no written notice is filed the filing 8 officer shall give effect to the party designation shown upon the first 9 document filed.)) If a candidate has: (a) Been nominated by two or more minor political parties or independent conventions; or (b) has 10 11 filed a declaration of candidacy declaring an affiliation with a major 12 political party and has been nominated by one or more minor political 13 parties or independent conventions, the candidate's name and political <u>party or independent candidacy will appear separately for each</u> 14 nomination or declaration. A candidate may be deemed nominated by a 15 minor party or independent convention only if all documentation 16 required by chapter 29A.20 RCW has been timely filed. 17

18 Sec. 9. RCW 29A.36.201 and 2004 c 271 s 171 are each amended to 19 read as follows:

20 The names of the persons certified as nominees by the secretary of 21 state or the county canvassing board shall be printed on the ballot at 22 the ensuing election.

No name of any candidate whose nomination at a primary is required by law shall be placed upon the ballot at a general or special election unless it appears upon the certificate of either (1) the secretary of state, or (2) the county canvassing board, or (3) a minor party convention or the state or county central committee of a major political party to fill a vacancy on its ticket under RCW 29A.28.021. If any person is nominated for the same office by two or more

30 parties, or is nominated for the same office by one or more parties in addition to appearing on the certificate of the secretary of state or 31 32 the county canvassing board, the name of the candidate shall appear on 33 the ballot for each nomination and certificate. Excluding the office of precinct committee officer or a temporary elected position such as 34 a charter review board member or freeholder, a candidate's name shall 35 36 not appear ((more than once upon a ballot for a position regularly 37 nominated or elected at the same election)) as a candidate for more 38 than one regularly nominated or elected office.

1NEW SECTION.Sec. 10.A new section is added to chapter 29A.602RCW to read as follows:

The candidate receiving the highest total number of legal votes for a specific office is the person elected to that office and shall be issued a certificate of election. If a candidate is nominated by more than one party for the same office, all votes for that candidate are aggregated to determine the result of the election.

8 **Sec. 11.** RCW 29A.60.200 and 2003 c 111 s 1520 are each amended to 9 read as follows:

Before canvassing the returns of a primary or election, the chair of the county legislative authority or the chair's designee shall administer an oath to the county auditor or the auditor's designee attesting to the authenticity of the information presented to the canvassing board. This oath must be signed by the county auditor or designee and filed with the returns of the primary or election.

16 The county canvassing board shall proceed to verify the results 17 from the precincts and the absentee ballots. The board shall execute 18 a certificate of the results of the primary or election signed by all 19 members of the board or their designees. Each statement shall set 20 forth, in words written out at length: All votes cast for all 21 candidates for each office; the name of each candidate; the number of votes so cast for each, and in the case of a candidate who was 22 23 nominated by two or more parties or independent bodies, the number, 24 separately stated, of votes cast for him or her as the candidate of 25 each party or independent body by which he or she was nominated; and 26 all votes cast upon any ballot proposal, and all the votes cast in 27 favor of and against the same, respectively. The statements shall show the total number of unrecorded or blank votes and the total number of 28 votes cast for each office and each ballot proposal. Failure to 29 30 certify the returns, if they can be ascertained with reasonable 31 certainty, is a crime under RCW 29A.84.720.

32 <u>NEW SECTION.</u> **Sec. 12.** The provisions of this act are to be 33 liberally construed to effectuate the intent, policies, and purposes of 34 this act.

35 <u>NEW SECTION.</u> Sec. 13. If any provision of this act or its 36 application to any person or circumstance is held invalid, the

1 remainder of the act or the application of the provision to other 2 persons or circumstances is not affected.

3 <u>NEW SECTION.</u> Sec. 14. This act may be known and cited as the open 4 ballot voting initiative.
